Greetings. Norwescon 28 is pleased to sponsor an Artists Alley. This will take place on the 1st floor between Wings 6 and 7 in the hotel. This is just past the Olympic rooms. Participation in this exciting addition to NORWESCON will be on a first come, first serve basis.

In addition to having a Norwescon 28 membership, a Washington State business license is required to sell anything in the Artists Alley. A temporary license may be obtained by calling the Department of Revenue at 1-800-647-7706. No one will be permitted to participate in the Artists Alley without this license, as we are now required by Washington State Law to have a copy of your license number.

The official artist space will be ½ of a 6' x 32" table. There may be 2 artists at a table. Artists are to provide their own materials.

No artist will be allowed to sell posters, books or other merchandise at this table. We do not want to be in direct competition with the Art Show or Dealers Room. You **may**, however, display your personal portfolios and take orders for those personal works in addition to the sketches you draw at the convention.

The displaying or sketching of an adult nature should be discreet. The artist assumes any and all liability for any damages (or claims arising out of damage to) the artist's display, equipment, or other property brought upon the premises of the Doubletree Seattle Airport Hotel and shall hold harmless the Doubletree Seattle Airport Hotel, its agents, services, and employees from any and all such losses, claims and damages.

By signing the Artists Alley application you agree to abide by all of the Norwescon 28 rules and regulations and the hotel agreement.
