Puzzle #1

Oh no! Miracle Max needs your help to whittle down this list of forty potential ingredients for Westley's miracle pill! Can you follow the instructions and cross off words in the diagram? When you are finished, you'll have the three ingredients Miracle Max needs! Some words may be eliminated by more than one of the instructions.

- 1. Cross out any ingredients with a double letter (meaning two M's like HAMMER, not like MEMO).*
- 2. Cross out any ingredients with a V or an X in the name.*
- 3. Cross out every ingredient in Row 4.*
- 4. Cross out any ingredient with fewer than three different vowels (A, E, I, O, or U).*
- 5. Cross out any ingredient that DOESN'T share at least three letters with the name WESTLEY.*

Puzzle #2

The ROUS Case

A brigand, a drifter, and an ROUS were all apprehended in the Fire Swamp after a guardsman searching for the princess went missing. Each was found with a different bit of evidence from the guardsman (his sword, his family crest, and a wound from a crossbow bolt). And remember, a wounded person or ROUS would travel slower than a healthy one.

Each suspect was found a different distance away from the last known sighting of the guardsman (2 miles, 3 miles, or 4 miles) and had a different excuse for not committing the crime ("I was stuck in the lightning sand," "I was cooking over a fire spurt," or "Grrrrrrr snarl grakkkk").

Using the evidence below, can you figure out which suspect had what evidence, what their excuse was, and how far away they were found? Most importantly, can you prove or refute the ROUS's innocence from the evidence provided?

- *The family crest, found near the lightning sand, was closest to the guardsman's last known location.*
- *The sword was discovered being used as a spit over the fire spurt, which was searched before the ROUS was found.*
- *The third clue for this case can be obtained from the Cute Squad agent.*
